
**Mr. Joyner moved that the minutes of the December 17, 2007, meeting be approved as read. Second by Mr. Douglas. The motion passed unanimously.**



Mrs. Guess reported that everything is on track for the South Fulton City election to be held in November 2008.


Discussion was held concerning the continuing need for more new precinct workers.


Katie Guess submitted a letter that was addressed to the County Mayor, Bennie Mcguire for a transfer of funds with-in our budget. The transfer is as follows:





**OBION COUNTY ELECTION COMMISSION  
MINUTES OF THE MEETING - JUNE 23, 2008**

Chairman John Algee called the meeting to order at 8:02 a.m. Also present were members Rob Joyner and Ethelene White; Administrator Katie Guess; and Deputy Leigh Schlager. Absent were members Ray Douglas and Dave Frankum.

**Mr. Joyner moved that the minutes of the March 24 meeting be approved as read. Second by Ms. White. The motion passed unanimously.**

Mrs. Guess reported that the Budget Committee of the County Commission had accepted the Election Commission's 2008-2009 budget as presented on May 30, at a total of \$226,611; a copy of the budget is included with these minutes. This is an increase of \$44,102 over the 2007-2008 budget of \$182,509, due to having two elections during the new budget year. Deputies' pay will be raised according to the percentage increase given to county employees.

**Ms. White moved to call the following elections as requested by each municipality, to be held with the November 4, 2008, State General Election. Second by Mr. Joyner. The motion passed unanimously.**

**TOWN OF HORNBEAK: one mayor and seven aldermen, for four-year terms;**

**TOWN OF OBION: one mayor and councilmen;**

**CITY OF SOUTH FULTON: one mayor elected city-wide and two city commissioners, one each for Districts 1 and 4;**

**TOWN OF TROY: one mayor and five aldermen, for two-year terms;**

**CITY OF UNION CITY: three members of the Board of Education, one each for Wards 2 and 4, and one member-at-large; and four city councilmen, one each for Wards 2, 3, and 5, and one at-large; all positions to be for four-year terms;**

**CITY OF WOODLAND MILLS: one mayor and two aldermen.**

Mrs. Guess reported that the Federal Government has paid 100% of the February 5, 2008, election rather than the anticipated 80%. A total of \$25,845.98 was received.

Mrs. Guess reported that cards for approximately 1,400 active South Fulton voters are ready to mail, notifying them of their current voting precinct based on the new city wards.

Discussion was held concerning recent State legislation on elections and voting machines.

Mrs. Schlager excused herself from the meeting. The commission reviewed the three monthly evaluations of Mrs. Schlager completed by Mrs. Guess, as required during her probationary period of employment. The commission approved continuation of Mrs. Schlager as a part-time deputy. Mrs. Schlager rejoined the meeting and was advised of the commission's decision.






**Mr. Joyner moved that the minutes of the September 15, 2008, meeting be approved as read. Second by Mr. Douglas. The motion passed unanimously.**




Mr. Algee reported on the visit to Hickman to observe the new voting machines for Fulton County.
